RESOLUTION

WHEREAS, the Board of Directors of South Texas Independent School District, Mercedes, Texas, pursuant to the authority granted by Texas Election Code 2.051-2.053, desires to participate in declaring each unopposed candidate elected to the office upon receipt of certification from the authority responsible for having the official ballot prepared;

WHEREAS, the South Texas Independent School District can declare each unopposed candidate elected to the office if each candidate whose name is to appear on the ballot is unopposed, and no proposition is to appear on the ballot;


WHEREAS, this will be highly beneficial to the taxpayers through the anticipated savings to be realized; now, therefore,

BE IT RESOLVED, that we the South Texas Independent School District Board of Directors declare the election for candidates whose names are to appear on the ballot unopposed for Hidalgo County, Precinct 2; Cameron County, Precinct 3; and Willacy County, Precincts 1, 4 and for whom no proposition is to appear on the ballot, as elected to the office according to Texas Election Code 2.052 & 2.053.

BE IT FURTHER RESOLVED that on election day, November 6, 2018, a copy of this Resolution be posted at each polling place that would have been used in the election for the purpose of informing the public that the following candidates for a place on the ballot are unopposed for election to the South Texas Independent School District Board of Directors, and are elected to the office according to the Texas Election Code:
